COVID-19 – Affected Municipal Services & Facilities

To help slow the rate of COVID-19 infection, Mayor Mayhew of Southwest Middlesex declared a local emergency. All municipal non-essential services are cancelled and facilities are closed to the public.

Effective Tuesday, March 24, 11:59 p.m., the Ontario Government ordered the mandatory closing of all non-essential workplaces. This action will be in effect for 14 days, with the potential for extension of the order as the situation related to COVID-19 continues to evolve. The municipality remains prepared to respond to emergencies.

[Animal Services Shelter](#) – 519-287-2974

The Glencoe Animal Shelter continues to operate, but with measures in place to limit interaction. The Shelter will respond to calls about a sick or injured animal, animals threatening public safety, and stray dog pickup. Dog bite investigations are proceeding, most likely in conjunction with the OPP.

On Friday, April 3, 2020, the [Provincial List of Essential Services](#) was expanded, and now includes impacts to the construction industry. It is the applicant's responsibility to ensure that they are following and keeping up to date with Provincial Orders as they relate to their projects. The municipality will continue to receive and process applications for building permits, however, despite the issuance of a permit, it is possible that an applicant may not be permitted to begin construction due to Ontario Regulation 82/20, or a further Provincial or Municipal Emergency Order.

There continue to be NO INSPECTIONS of an occupied dwelling or building. Applications and payments may be submitted to the mail drop box and received by making an appointment with dgiles@southwestmiddlesex.ca or by calling and leaving a message.

Council and Committee Meetings

Regular meetings of council (by electronic participation) are being held in a virtual format starting April 8, 2020 and will be streamed live on our website (<https://www.southwestmiddlesex.ca/Public/Council-Committees-Agenda-Minutes>) for the public. Committee meetings have been postponed. A special, or emergency, meeting can be called to discuss urgent business as required.

Emergency Response – 9-1-1

Fire Department

The Southwest Middlesex Volunteer Fire Department continues to respond to emergency calls. Training and other events are temporarily cancelled.

Police (Ontario Provincial Police)

Middlesex-London Emergency Medical Services (MLEMS)

MLEMS continues to provide 24-hour emergency and non-emergency pre-hospital medical care and transportation to individuals experiencing injury or illness.

Emergency Management

The Emergency Control Group (ECG) for SWM met in response to COVID-19, and the pandemic response is led by the Medical Officer of Health for Middlesex-London. The municipality continues to promote the recommendations and follow directions and orders from the health unit.

Parks and Playgrounds

Our playground structures are closed to the public, following direction received on the afternoon of March 23, 2020 from the Medical Officer of Health (and then required by the Province as of March 30).

On the evening of March 30, 2020, the Province of Ontario ordered the closure of all outdoor recreational amenities. For our municipality, this means that in addition to playground structures being closed, that the tennis courts at the high school are closed, as well as the skateboard park beside the

arena, the dog park beside the Glencoe water tower, all of the pavilions, baseball diamonds and soccer fields.

Parks are still open, but the public is reminded to follow the advice of the Health Unit regarding COVID-19. Individuals who are sick, or who have recently returned from abroad, should self-isolate, and all others should be practicing social distancing and respiratory etiquette.

Planning

Land use planning inquiries will be responded to either via telephone or email.

Police

Emergency calls (involving and immediate threat to life or property) are being responded to. Non-emergency incidents can be reported to or using the online reporting system.

Be extra vigilant when it comes to people trying to sell or provide products or services associated with COVID-19. If you believe that you have been approached by someone misrepresenting themselves in an effort to sell goods or services, report it to the police online.

OPP detachments are locked, but not closed. Before a member of the public is allowed into the building, they are required to pick up the phone outside the detachment where they will be screened for COVID-19 symptoms. If the matter can be dealt with over the phone, it will be.

Fingerprinting and Criminal Records Checks continue for employment purposes only.

During the emergency, and for 30 days following, the municipality will not apply interest and penalties to outstanding water, property tax, or dog tag accounts.

What this means for our residents is, if COVID-19 situation has impacted the earnings in your household, Council is reassuring you that you will not be penalized for not paying your water/tax/dog tag invoices immediately.

Once the state of emergency has been lifted, you will have one month to catch up on the outstanding invoices until the regular practice of applying interest and penalty will be resumed.

While the municipal office is closed, we will be continuing to check the mail and drop box should any payments come in, and we continue to take payments online through most banking institutions.

Public Consultations

All public consultations are cancelled, including those hosted by Planning.

Recreation and Community Centres

All recreation programs cancelled.

Glencoe & District Lions Club's White Elephant Sale is tentatively rescheduled until late June.

South Middlesex Acting Krew's spring production in Appin is cancelled.

Upcoming spring & summer recreational programs could be subject to delayed start dates, depending on the length of the pandemic.

Road and Sidewalk Maintenance

Water and Wastewater

Critical water and wastewater operations will continue and include:
