

**THE MUNICIPALITY OF SOUTHWEST MIDDLESEX
BY-LAW NO. 2018/088**

**Being a by-law to establish Municipal Service Board and Committees
along with their respective appointments of the Municipality of Southwest Middlesex**

WHEREAS the Municipal Act, S.O. 2001, c. 25 Section 8 states a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS Section 9(1) states that Sections 8 and 11 shall be interpreted broadly so as to confer broad authority on municipalities, to enable them to govern their affairs as they consider appropriate; and to enhance their ability to respond to municipal issues;

AND WHEREAS Section 11(2)(3) states if a sphere or part of a sphere of jurisdiction is assigned to an upper tier municipality non exclusively by the Table, both the upper tier and its lower tier municipalities have the power to pass bylaws under that sphere or part;

AND WHEREAS Economic Development Services and culture, parks, recreation and heritage are assigned by the Table as non-exclusive;

NOW THEREFORE be it ENACTED AS FOLLOWS:

1. That the Municipality of Southwest Middlesex establishes the following Municipal Service Boards and/or Committees and their respective appointments for the term of council, or where an external board/committee appointment exists, as per the term set out by such board/committee.
 1. Economic Development Committee – Allan Mayhew (ex officio), Doug Bartlett, Mike Sholdice, Mark McGill, Christa Cowell
 2. Brooke-Alvinston Fire Board – Martin Vink
 3. Four Counties Transportation – Ian Carruthers, Marigay Wilkins
 4. Lower Thames Valley Conservation Authority – Martin Vink
 5. St. Clair Region Conservation Authority (appointment shared with Village of Newbury) – Mark McGill
 6. Tri-County Water Board – Allan Mayhew, Marigay Wilkins, Doug Bartlett, alternate Jill Bellchamber-Glazier
 7. Canada Day Committee – Allan Mayhew (ex officio), Ian Carruthers, Jeremy Feasey, Barbara Pinnell (secretary)
 8. Communities in Bloom – Ian Carruthers, Mike Sholdice
2. That the Economic Development Committee, the Canada Day Committee and the Communities in Bloom Committee shall including volunteer board members as named by the executive.
3. That By-law No.'s 2003/049, 2005/050, 2006/054, 2007/048, 2007/049, 2008/041, 2009/043, 2010/056, 2011/047, 2012/047, 2013/057, 2014/076, 2015/061, 2016/060, 2017/005 and 2017/063 and 2018/046 are hereby repealed.


