# Purpose and Effect of the Application

The purpose and effect of the application for Minor Variance is to seek relief from the Southwest Middlesex Comprehensive Zoning By-law No. 2011/065, Section 4.26 in order to permit the establishment of a 3.5 m² business sign located approximately 3.7 m from both the front and exterior side lot lines (within the sight visibility triangle, in accordance with the concept plan), whereas no building or structure shall be erected and no shrubs or foliage planted in such manner as to impede the vision of a motorist approaching the intersection, between a height of one (1.0) metre and three (3.0) metres above the centre line grade of intersecting roads in the triangular area bounded by the front lot line, the exterior side lot line and a line joining the points along said lines nine (9.0) metres distant from the point of intersection of the said lines. (See concept plan attached).

The subject lands contains a dental office (Glencoe Dental Care), and are otherwise vacant of any buildings or structures. The lands contain a municipal sanitary and municipal water connection, and has an existing access off of Symes Street.

The subject lands are designated 'Residential' within the Southwest Middlesex Official Plan, and are zoned 'Residential First Density (R1(1)' within the Southwest Middlesex Zoning By-law.

### Location and Description of Subject Property

The subject lands are located at the southwest corner of Currie Street and Symes Street in Glencoe. The lands are legally described as Plan 159, Block 'l' Part Lots 1 & 2, Municipality of Southwest Middlesex. (See Location Map)


