Purpose and Effect

The purpose and effect of Application for Consent B24-2024 is to sever a parcel of land to facilitate the disposal of a surplus farm dwelling as a result of farm consolidation. The lands as a whole have an area of approximately 19.89 ha (49.2 ac) and a frontage of approximately 310 m (1,017 ft). The lands proposed to be retained would have a frontage of approximately 18 m (59 ft) along Longwoods Road (County Road 2) and an area of approximately 0.65 ha (1.6 ac). The lands contain a single detached dwelling and detached garage and are serviced by a private well and private septic system. These lands have an existing access from Longwoods Road (County Road 2). The lands proposed to be severed would have a frontage of approximately 292 m (958 ft) along Longwoods Road (County Road 2) and an area of 19.24 ha (47.5 ac). The severed lands contain agricultural land in crop production, as well as a barn and two silos which are to be removed. Confirmation of an existing access off of Longwoods Road, or the establishment of a new access will be required as a result of the severance. A location map is attached for reference.

Description and Location of Subject Lands

The subject lands are located on the north side of Longwoods Road (County Road 2) between Mayfair Road and Springfield Road. The lands are legally described as Part of Lot 8, Range 1N, Municipality of Southwest Middlesex (Ekfrid).


Submissions during the Oral Submissions of Delegates (Part D) part of the meeting are encouraged whenever possible.


