Purpose and Effect

The purpose and effect of Application for Consent B25-2024 is to sever a parcel of land to facilitate the disposal of a surplus farm dwelling as a result of farm consolidation. The lands as a whole have an area of approximately 40.47 ha (100 ac) and a frontage of approximately 600 m (1,968.5 ft). The lands proposed to be severed would have a frontage of approximately 260 m (853 ft) along Switzer Drive and an area of approximately 1.8 ha (4.46 ac). The lands proposed to be severed contains a single detached dwelling and are serviced by a private well and septic system. These lands have an existing access from Switzer Drive. The lands contain natural heritage features including significant woodlands and would be bordered by a watercourse.

The lands proposed to be retained would have an approximate frontage of 341 m (1,118.77 ft) along Switzer Drive and an area of 39.1 ha (96.54 ac). The retained lands contain a single detached dwelling, several farm buildings and is used for agricultural purposes in the form of field crop cultivation. The retained lands also contain natural heritage features including significant woodlands. The retained lands have an existing access from Switzer Drive.

A location map is attached for reference.

Description and Location of Subject Lands

The subject lands are located on the south side of Switzer Drive and between Tait's Road and Dundonald Road. The lands are legally described as North Part of Lot 22, Range 2S, Municipality of Southwest Middlesex (Ekfrid).


